Defendants must attend by Audio Visual Link (AVL) in the event a plea is to be entered at the callover. Defendants may also attend by AVL for other reasons should their legal representative require them. In either case defendant legal representatives **must notify the court by email to MCListings@courts.act.gov.au by 4pm on Wednesday 29 April 2020** so that an order for production can be issued.

The court expects parties to attend with the following information

- a. if a guilty plea is to be entered in any matter, all efforts will be made to have agreed facts, a criminal history and other evidence which may be relied upon for sentence, or a clear indication of when they will be available;

- b. If the not guilty plea is maintained, witness requirements and if practicable any admitted facts are to be provided along with notice of any special arrangements that may be required and a best time estimate;

The issue of bail will not be considered at this callover unless any proposed change to the defendant's in custody status is by agreement of the parties.
